



# Annual Disclosure Statement for the 12 month period ended 31 March 2015 Lifestages KiwiSaver Scheme Lifestages Growth Portfolio

## What is the purpose of this statement?

This statement provides key information about the Lifestages KiwiSaver Scheme - Lifestages Growth Portfolio. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

## Description of the fund

The Lifestages Growth Portfolio aims to provide capital growth over the long term. The majority of the Lifestages Growth Portfolio is invested in shares and as such its return is likely to fluctuate in line with sharemarkets worldwide.



Members were also charged **membership fees**<sup>3</sup> of \$24.00 over the year.


### Example of how this applies to a member

Caleb had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Caleb received a return after fund fees and tax were deducted of \$1,179 (that's 11.79% of his initial \$10,000). Caleb also paid \$24.00 in membership fees. This gives Caleb a total return of \$1,155.00 for the year.
