What is the purpose of this update?

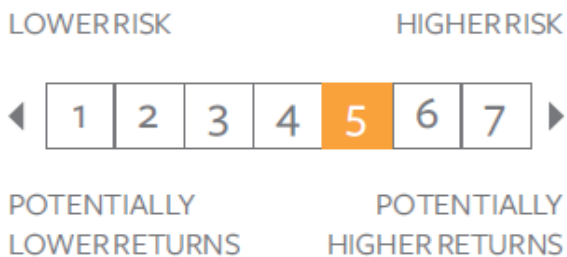
Description of this fund

The fund aims to achieve capital growth and returns over the long-term through investment primarily in a broad spread of international equities. The fund offers a multi-manager approach to equity investing.

What are the risks of investing?

Risk indicator for the Lifestages World Equity Portfolio:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

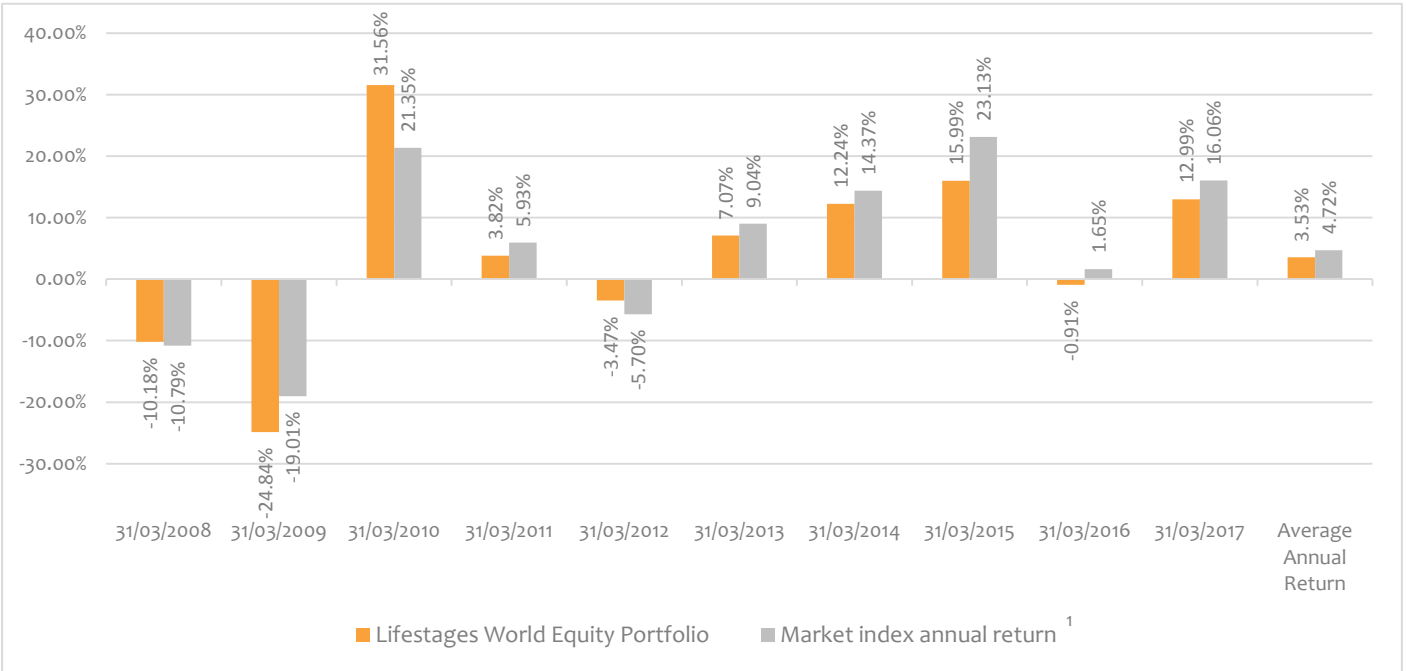
How has the fund performed?

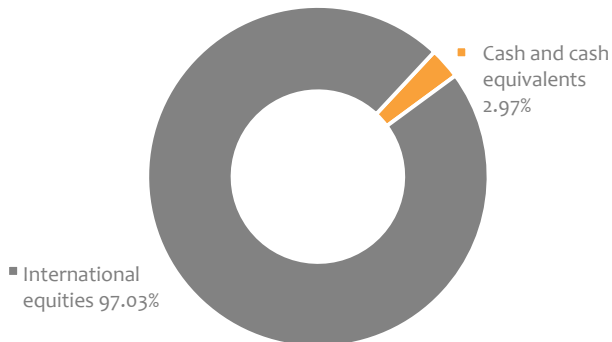
Example of how this applies to an investor

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$1,392 (that is 13.92% of her initial \$10,000). This gives Hayley a total return after tax of \$1,299.00 for the year.

Currency hedging

Currency hedging can apply to some of the asset classes this fund invests in. The level of currency hedging for foreign assets is managed to a target of 50%. This may change over time depending on the Manager's view of the relative strength (or weakness) of the New Zealand dollar.

Our estimates are made on the basis of reasonable assumptions about the ongoing level of fees and costs expected to be charged (taking into account the actual fees and costs as a percentage of average net asset value that were charged for the most recent scheme year). These fees are deducted from, and reflected in the unit price of the fund.
