What is the purpose of this update?

This document tells you how the Lifestages World Equity Portfolio has performed and what fees were charged. The document will help you to compare the fund with other funds. Funds Administration New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund aims to achieve capital growth and returns over the long-term through investment primarily in a broad spread of international equites. The fund offers a multi-manager approach to equity investing.



Example of how this applies to an investor


Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$1,805 (that is 18.05% of her initial \$10,000). This gives Hayley a total return after tax of \$1,707.00 for the year.

Currency hedging

Currency hedging can apply to some of the asset classes this fund invests in. The level of currency hedging for foreign assets is managed to a target of 50%. This may change over time depending on the Manager's view of the relative strength (or weakness) of the New Zealand dollar.
