# Description of this fund

The fund aims to achieve capital growth and returns over the long-term through investing primarily in a broad spread of New Zealand and Australian equities. The fund offers a multimanager approach to equity investing.



#### Example of how this applies to an investor


Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$602 (that is 6.02% of her initial \$10,000). This gives Hayley a total return after tax of \$510.00 for the year.
