
Description of this investment option

This life cycle investment stage is 100% invested in the Lifestages High Growth Fund, which is regarded as providing appropriate levels of risk and return for a person aged 0-34.

What are the risks of investing?

Risk indicator for the Lifestages Auto Option age 0 - 34:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the investment option's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Example of how this applies to an investor


Hayley had \$10,000 in the investment option at the start of the year and did not make any further contributions. At the end of the year, Hayley incurred a loss after fund charges were deducted of -\$491 (that is -4.91% of her initial \$10,000). Hayley also paid \$24.00 in other charges. This gives Hayley a total loss after tax of -\$625.00 for the year.

Currency hedging

As at 31 December 2018 the fund has an exposure to foreign currency assets of 81.11%, of which 25.36% was hedged back to NZD. This means the fund's foreign currency exposure is 55.75%.
