What is the purpose of this update?

This document tells you how the Lifestages Auto Option age 65+ has performed and what fees were charged. The document will help you to compare the investment option with other investment options and funds. Funds Administration New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this investment option

This life cycle investment stage invests 25% in the Lifestages High Growth Fund and 75% in the Lifestages Income Fund, which is regarded as providing appropriate levels of risk and return for a person aged 65+.



Example of how this applies to an investor


Hayley had \$10,000 in the investment option at the start of the year and did not make any further contributions. At the end of the year, Hayley incurred a loss after fund charges were deducted of -\$85 (that is -0.85% of her initial \$10,000). Hayley also paid \$24.00 in other charges. This gives Hayley a total loss after tax of -\$212.00 for the year.

Currency hedging

As at 31 December 2018 the fund has an exposure to foreign currency assets of 65.32%, of which 51.03% was hedged back to NZD. This means the fund's foreign currency exposure is 14.29%. - ² This covers expenses incurred in running the fund (e.g. accounting, audit, and regulatory compliance costs). GST will be included in some expenses, where applicable.
