## What is the purpose of this update?

This document tells you how the Lifestages World Equity Portfolio has performed and what fees were charged. The document will help you to compare the fund with other funds. 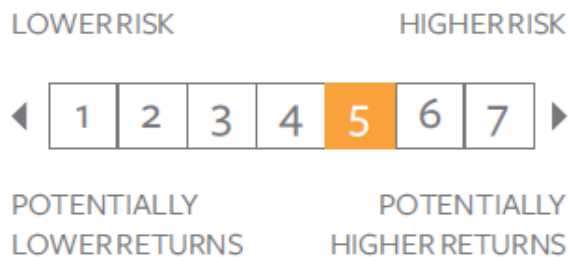
## Description of this fund

The fund aims to achieve capital growth and returns over the long-term through investment primarily in a broad spread of international equities. The fund offers a multi-manager approach to equity investing.

## What are the risks of investing?

Risk indicator for the Lifestages World Equity Portfolio:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

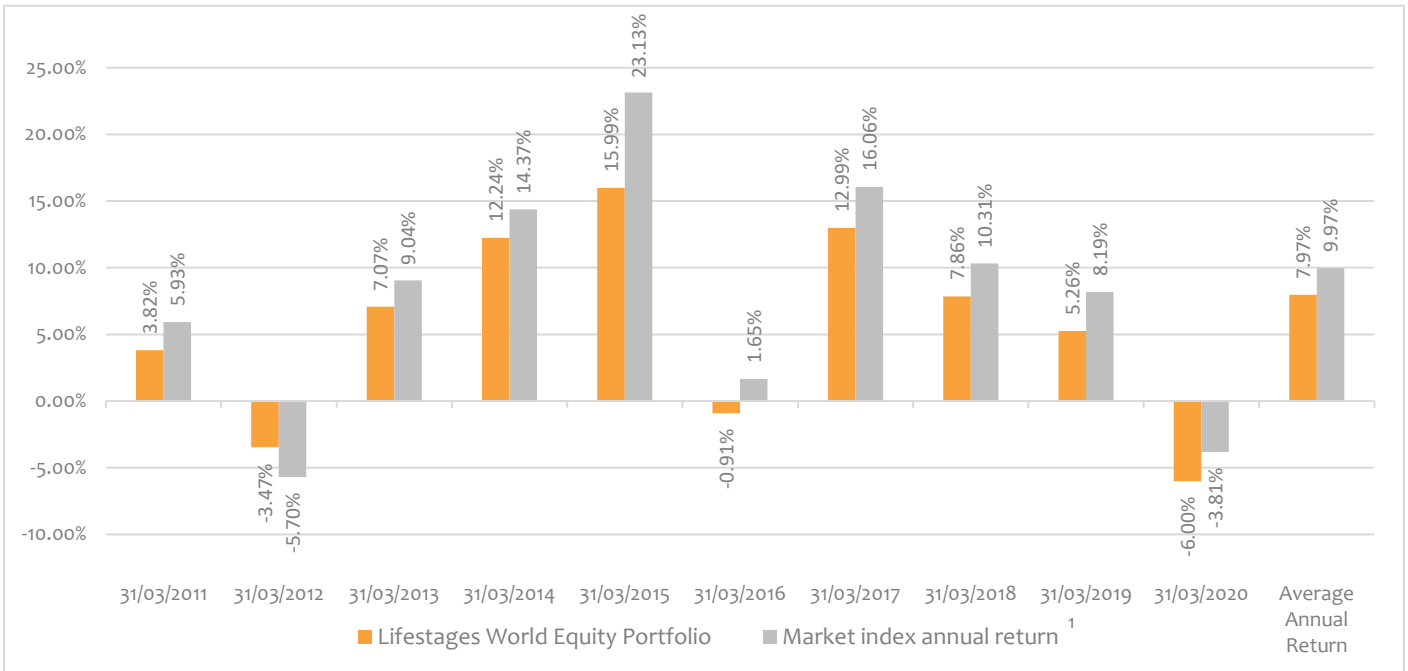
## How has the fund performed?

The market index annual return is based on a composite index, calculated using the target investment mix weightings of the underlying market indices that the fund invests into. The benchmark indices used for each asset class are defined in the Statement of Investment Policy and Objectives (SIPO).

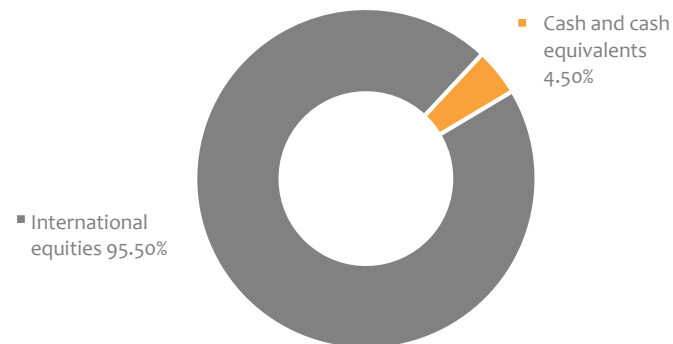
### Example of how this applies to an investor

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$386 (that is 3.86% of her initial \$10,000). This gives Hayley a total return after tax of \$294.00 for the year.

The top 10 investments make up 100.59% of the net asset value of the fund.

### Currency hedging

As at 30 June 2020 the fund has an exposure to foreign currency assets of 95.50%, of which 52.03% was hedged back to NZD. This means the fund's foreign currency exposure is 43.47%. Our estimates are made on the basis of reasonable assumptions about the ongoing level of fees and costs expected to be charged (taking into account the actual fees and costs as a percentage of average net asset value that were charged for the most recent scheme year). These fees are deducted from, and reflected in the unit price of the fund.
