# What is the purpose of this update?

This document tells you how the Lifestages High Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Funds Administration New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

# Description of this fund

The fund aims to provide investors with capital growth over the long-term, by investing primarily in a broad spread of New Zealand and international growth assets, with a small amount held in cash.

# What are the risks of investing?

Risk indicator<sup>1</sup> for the Lifestages High Growth Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

#### Example of how this applies to an investor


Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$675 (that is 6.75% of her initial \$10,000). Hayley also paid \$24.00 in other charges. This gives Hayley a total return after tax of \$555.00 for the year.

### Currency hedging

As at 31 December 2020 the fund has an exposure to foreign currency assets of 76.73%, of which 27.55% was hedged back to NZD. This means the fund's foreign currency exposure is 49.18%. ### Notes

- <sup>1</sup> As the Fund has not been in existence for 5 years, a combination of actual returns and market index returns have been used to calculate the Fund's risk indicator. Market index returns and benchmark weightings have been used up to October 2015 when the Fund commenced. The risk indicator may therefore provide a less reliable indicator of the potential future volatility of the Fund.
- <sup>2</sup> Note that market indices reflect no deduction for charges and tax.
- <sup>3</sup> This covers expenses incurred in running the fund (e.g. accounting, audit, and regulatory compliance costs). This also covers the Supervisor's annual fee (for the services it provides) and an estimate of fees and expenses incurred by the underlying funds. GST will be included in some expenses, where applicable. Our estimates are made on the basis of reasonable assumptions about the ongoing level of fees and costs expected to be charged (taking into account the actual fees and costs as a percentage of average net asset value that were charged for the most recent scheme year). These fees are deducted from, and reflected in the unit price of the fund.
