## What is the purpose of this update?

This document tells you how the Lifestages World Equity Portfolio has performed and what fees were charged. The document will help you to compare the fund with other funds. Funds Administration New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The fund aims to achieve capital growth and returns over the longterm through investment primarily in a broad spread of international equites. The fund offers a multi-manager approach to equity investing.

# What are the risks of investing?

# How has the fund performed?



# Example of how this applies to an investor


Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley incurred a loss after fund charges were deducted of -\$1,003 (that is -10.03% of her initial \$10,000). This gives Hayley a total loss after tax of -\$1,087.00 for the year.

# **Currency hedging**

As at 30 September 2022 the fund has an exposure to foreign currency assets of 92.27%, of which 36.76% was hedged back to NZD. This means the fund's foreign currency exposure is 55.51%.
