
Description of this fund

The fund aims to achieve capital growth and returns over the longterm through investment primarily in a broad spread of international equites. The fund offers a multi-manager approach to equity investing.

What are the risks of investing?

Risk indicator for the Lifestages World Equity Portfolio:

How has the fund performed?



Example of how this applies to an investor

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley incurred a loss after fund charges were deducted of -\$1,543 (that is -15.43% of her initial \$10,000). This gives Hayley a total loss after tax of -\$1,625.00 for the year.

Currency hedging

As at 31 December 2022 the fund has an exposure to foreign currency assets of 95.80%, of which 43.31% was hedged back to NZD. This means the fund's foreign currency exposure is 52.49%.
