
Description of this fund

This life cycle investment stage invests 80% in the Lifestages High Growth Fund and 20% in the Lifestages Income Fund, which is regarded as providing appropriate levels of risk and return for a person aged 50-54.

What are the risks of investing?

Risk indicator for the Lifestages Auto Option age 50 - 54:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the investment option performed?



From 1 December 2022, the \$24 annual Member fee was removed. The total fund charges are expected to be 1.09% per annum from 1 December 2022.


Example of how this applies to an investor

Hayley had \$10,000 in the investment option at the start of the year and did not make any further contributions. At the end of the year, Hayley incurred a loss after fund charges were deducted of -\$1,378 (that is -13.78% of her initial \$10,000). Hayley also paid \$24.00 in other charges. This gives Hayley a total loss after tax of -\$1,480.05 for the year.

Currency hedging

As at 31 December 2022 the investment option has an exposure to foreign currency assets of 75.71%, of which 37.08% was hedged back to NZD. This means the investment option's foreign currency exposure is 38.63%. - ¹ Note that market indices reflect no deduction for charges and tax.
